Any defect arising from fair wear and tear, wilful damage, negligence, abnormal working conditions, misuse, alteration or repair, exposure to saltwater environments, or exposure to corrosive chemicals, without consent will render all claims null and void.

Any claims under this warranty must be made in writing within one month of occurrence of the defect. Any further claims, particularly claims for damages, are not covered by the warranty. Parts delivered as or for replacement are new or equivalent and in operative condition. Original parts shall be returned and will become property of the manufacturer.

Conditions for warranty cover:

- 1. The equipment has been used for its intended use.
- 2. The equipment can be identified by means of identification label, brand marking or evidence that it is an IP ENCLOSURES product.
- 3. The equipment has not been modified in any way, unless authorised by IP ENCLOSURES.
- 4. The equipment has not been affected by external factors such as vandalism, intentional or accidental damage, fire etc.
- 5. The equipment has not been damaged during handling, assembly, fitting or installation.
